

KEGG FTP ACADEMIC SUBSCRIPTION

END USER AGREEMENT

This is the KEGG FTP Academic Subscription End User Agreement (the “**Agreement**”) governing Your use of the KEGG FTP site for academic users.

In the spirit of academic cooperation, Kanehisa Laboratories serves the international research community with the freely available KEGG website. To ensure the sustainability of the KEGG project, Kanehisa Laboratories has appointed Pathway Solutions Inc. for maintaining the KEGG FTP site and for handling subscription services. To be able to access the KEGG FTP site and download and use KEGG FTP Data, you must first agree to the terms of this Agreement.

The following definitions are intended to clarify the various terms that we use in this document:

“**Pathway**”, “**Licensors**” means Pathway Solutions Inc., the exclusive KEGG licensing agent, who shall process all subscriptions on behalf of Kanehisa Laboratories for all academic users.

“**KEGG**” means the database known as the Kyoto Encyclopedia of Genes and Genomes developed by Kanehisa Laboratories and provided electronically via the KEGG website (<https://www.kegg.jp>) or via any mirror site and any software embodied therein, the data contained therein, and any modified, updated or enhanced version thereof.

“**KEGG FTP Data**” means any or all of the data in KEGG, provided electronically to authorized licensees by Pathway via the KEGG FTP site (<https://ftp.kegg.net>).

“**KEGG Based AI/ML Model**” means assemblies generated from artificial intelligence and/or machine learning algorithms applied to KEGG FTP Data.

“**Licensee**”, “**You**”, “**Your**”, etc. means you, the user of KEGG FTP Data, and your collaborators in the same organization as you. You confirm that You and your collaborators are employees or researchers of an academic or public institution, that You and your collaborators are not working in collaboration with a commercial entity, and that You and your collaborators are not providing for-profit products or services.

In consideration of Your agreement to comply with the terms and conditions of this Agreement, and provided that You pay an applicable subscription fee, the Licensors hereby grants You a non-exclusive, and non-transferable license (“**License**”) to (i) access the KEGG FTP site and download KEGG FTP Data, (ii) use KEGG for your own research, and (iii) publish the results of such research including KEGG FTP Data. This License will terminate when your subscription expires.

This Agreement does not grant You any rights to patents, copyrights, trade secrets, trade names, trademarks (whether registered or unregistered), or any other rights, functions or licenses in respect to the KEGG FTP Data not explicitly contained herein.

You agree to not distribute or share KEGG FTP Data that you obtain via this subscription.

Upon expiration or termination of your subscription, You agree to delete all of KEGG FTP Data held by You and permanently destroy any KEGG Based AI/ML Model.

THERE IS NO WARRANTY FOR ANY OF THE DATA OR THE ACCURACY THEREOF, TO THE EXTENT PERMITTED BY APPLICABLE LAW. THE LICENSOR PROVIDES THE KEGG FTP DATA “AS IS” WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
