

## **KEGG FTP ACADEMIC SUBSCRIPTION**

### **FOR SINGLE END USER**

This is the **KEGG FTP Academic Subscription for Single End User** (“**Subscription**”) governing Your use of the KEGG FTP site for academic users.

In the spirit of academic cooperation, Kanehisa Laboratories serves the international research community with the freely available KEGG website. To ensure the ongoing financial support of the KEGG project, Kanehisa Laboratories is providing KEGG FTP access rights to academics for a fee. Kanehisa Laboratories has appointed Pathway Solutions Inc. for handling subscription services. To be able to access the KEGG FTP site and download and use KEGG FTP Data, you must first agree to the terms of this Subscription provided to You by Kanehisa Laboratories.
